

Q: Why am I being prompted by MetLife Legal Plans to add my legal documents to Aura Vault?

A: You are seeing a prompt to safeguard your documents in the Aura Vault because your employer offers you access to MetLife and Aura Identity & Fraud protection.

If you are enrolled in Identity & Fraud Protection, either as a standalone voluntary benefit or if access to the service is included in your MetLife Legal Plans benefit, you can link your Aura account to the Legal Plans portal for seamless, secure document storage and access them in the Vault anytime.

Q: I did not enroll in MetLife and Aura Identity & Fraud Protection. Can I still use Vault?

A: No, Vault is only available if you are enrolled in MetLife and Aura Identity & Fraud Protection. If you enroll in the future, the Vault feature will be unlocked. In the meantime, you can access a digital copy of your Digital Estate Plan and other documents in your Legal Plans member portal.

Q: I enrolled in MetLife and Aura Identity & Fraud Protection but did not enroll in MetLife Legal Plans. Can I still use an attorney through MetLife Legal Plans?

A: No, services included in MetLife Legal Plans are only available to those who enrolled in the benefit.

Q: If my MetLife Legal Plans includes access to Identity Protection/Aura, where in the Legal Plans member portal can I activate my Aura coverage?

A: From the Legal Plans member portal, click on the Debt Matters tile, then click the "select" button next to Identity Protection.

Note: If you see Identity Restoration but do not see Identity Protection, this means your Legal Plans includes access to identity restoration services if you become a victim of ID theft but does **not** include Aura's proactive identity protection solution.

Q: When I click the link in the Legal Plans portal to add my completed Digital Estate Planning documents to the Aura Vault, why am I seeing an error that my information cannot be verified?

A: If you've already activated your Aura account, please use the Sign In option to link your credentials. The Personal Identifiable Information (PII) Verification option will only work for new users who are accessing their Aura account for the first time.
